Let's hope for calmer waters on Saturday, Sept. 30<sup>th</sup> for a fun day of fishing, food and music! We kick off the day with the derby, followed by a BBQ and music provided by the High Hopes Reggae band. Entry fee includes concert, T-shirt, BBQ and plenty of refreshments. **Music from 2:30 – 4:30pm**

Entry Fee: \$35 for adults / \$10 for juniors (16 & under)

BBQ & Concert only: \$20 (BBQ starts at 1:00 pm)

Concert only: \$10 (**High Hopes performs from 2:30- 4:30**)

Note: You can sign up at the door for the concert only, fishing and BBQ must be paid in advance.

## **RULES:**

- Lines in no earlier than 5:00 am. Fish must be weighed in by 1:00 pm. Participants must return to the Club docks to weigh in fish.
- No fish caught from shore may be entered in the contest, no fishing allowed on Club grounds.
- Each individual is responsible for their catch.
- Decision of the judges is final and binding on all contestants.

## **PRIZES:**

Prizes will be awarded based on weight of the bluefish caught by the contestant. Prizes as follows: 1st, 2nd, and 3rd place cash prizes awarded in each division: Mens, Womens, Juniors (16 & under)

The Calcutta participant weighing in the heaviest bluefish takes the entire prize. \$50 per boat!
